DRVS aligns with SAMHSA's HIT priorities to help CCBHCs deliver high-impact care through:

- **Care Delivery:** Point of care tools support clinical decision making and evidence-based care
- **Care Coordination:** Track referrals, share care plans, and use alerts to support person-centered care
- **Health Information Exchange (HIE):** Connect via ADT feeds to manage transitions and flag follow-up
- **Population Health Management:** Identify inequalities, view dashboards and generate reports for quality improvement and funders

DRVS Features

In addition to core functionality, DRVS also supports CCBHCs with the following:

- **Patient Visit Planning:** CCBHC clinic collected measures and associated point of care alerts on the Patient Visit Planning Report (PVP)
- **CCBHC Scorecard:** Behavioral Health eQMs for clinic-collected measures
- **Cohort Identification:** Segment CCBHC populations with dynamic filters and exclude from UDS as needed
- **Shared Data Access:** Access cross-site data (labs, meds, diagnoses) from partner EHRs for integrated care planning
